### **Conference Training Opportunities**

There will be two opportunities for training this year.

During the opening session, the State Auditor and Inspector will be presenting **A Byrd's Eye View on An Investigative Audit**. State Auditor Cindy Byrd will discuss the divisions of the State Auditor's Office and the various types of government audits that are vital to the accountability of tax dollars in our state. The session will include a detailed presentation of the Governor's investigative audit request of Epic Charter Schools which highlights a for profit education management company and its two owners.

On Thursday, the Office of the State Auditor and Inspector will be presenting **Coronavirus State and Local Fiscal Recovery Funds – the County's responsibilities for federal relief funds**. This will include what documentation auditors will be looking for during the audit.
